REGISTRATION

TERMS AND CONDITIONS OF PARTICIPATION

1. Transportation of exhibits to and from the exhibition and arrangements in the exhibition space are the sole responsibility of the exhibitor and on his account. The exhibitor will not obstruct aisles, approaches to the exhibition area and in no way cause inconvenience to other exhibitors.
2. All exhibits must be within the allocated exhibition area an hour before the opening of the exhibition. Exhibits must not be removed during opening hours.
3. All arrangements by the exhibitor inside his exhibition area must comply with safety regulations.
4. The organizers reserve the right to alter the layout of the exhibition, postpone or cancel it, or move the exhibition to a different location.
5. The organizers are obliged to assure the orderly operation of the exhibition by all means at their disposal.
6. Exhibitors may not take their exhibits to areas outside the areas allocated to them, without prior permission from the organizers.
7. The organizers, while providing general security, are not responsible for theft or damage to exhibitor's property.
